



RESOLUTION 2026 APPLICATION FORM TIPS

General Application Notes and Tips

- The application form is a Microsoft form.
- Please note you can't save it and come back later so we recommend typing up what you want to say and copy and pasting into the form when you are ready. You can use the practice application form for this.
- Please keep your answers as clear and concise as possible and check your word counts.
- For Section 2 of your application, we want applicants to be able to talk about their work in the way that best suits them. For this section, if you would prefer, you can paste a link to online material (video or audio) of you describing your work. However, if answering in this format, please answer all the questions provided so that we can get a sense of your work.
- Please note that you can only submit one application per choreographer/company.
- If a question has a * next to it then you must complete the question to move onto the next section.

Section 1- CONTACT INFORMATION

Q. Choreographer Name and/or Company Name

Please enter whichever name you would prefer to be referred to in marketing materials. If you are applying as an individual

choreographer then you can enter this here, if you are applying on behalf of a company/collective, enter the company/collective name here.

Q. Choreographer/Company email

We may need to contact you by email or phone while we are processing your application and afterwards during the season, so please make sure your contact details are correct. If they change at any point email us with your correct info so we can contact you.

If you are applying as a company, please make sure that the person you give as the lead contact is easy to contact and has a full understanding of the application. This person will be named on the contract and will be responsible for the financial details after the performance.

Please also provide us with a link to your website if you have one.

Q. If the choreographer is contracted to a dance company on a full-time basis, they must provide a letter of permission from the company allowing them to take part in Resolution if they are selected.

Likewise, if you use performers who are contracted to another company on a full-time basis, we strongly recommend gaining permission for any days off in advance to avoid last minute casting changes or issues with performance dates.

Q12. Have you ever shown your work at Resolution before?

We ask for the type of company you are, the two options are:

First Footing: A company or choreographer who has not previously shown work in Resolution.

Evolution: A company or choreographer who has previously shown work in Resolution.

Section 2- TELL US ABOUT YOUR IDEA

You can answer the following question either by writing answers, or by including an audio or video recording of your answers in the box provided. Please make any recordings concise, clear and ensure the sharing settings are correctly enabled!

Q. What is the title of your piece?

Please indicate the title of the piece and note that this can be changed at a later stage.

Q. What is the duration of the work in minutes?

Please indicate how long you intend the piece to be, we will not consider any works shorter than 15 minutes or longer than 25 minutes. Again, this can be approximate as we know you might not have an exact length at this stage.

Q. How many dancers will perform on stage in the work?

Please tell us how many dancers you expect will perform on stage in the piece.

Q. How many additional performers will be on stage during the show? E.g., singers, musicians, actors.

It is also imperative that you answer how many people will be on stage during the performance as we take this information into account when pairing your work up with other companies.

Q. Will there be any live music in the performance?

You must tell us if there will be any live music in the performance as this helps us to plan and programme the festival technically and to decide on running orders.

Q. Please give a short description of the work. (E.g., what is the actual idea you are exploring, what is the atmosphere, is it abstract or narrative? Is it contemporary, circus, hip hop, or a fusion of styles?) 200 words max.

This section is extremely important to the application. This is your opportunity to tell us more about your piece and why you want to do it. In this section we want you to tell us about the piece you are applying with, giving detail about the performance to help us to envisage how the piece will look – its content, its staging and its overall feel.

Try and avoid statements such as: ‘XY Dance Company are a fresh young company who will blow your mind with their exciting digital dance work’.

Instead, focus on the **what:** Who is in the space? Is it abstract or narrative? What is the atmosphere?

We recommend talking the idea through out loud to a friend or someone not involved in the work first.

We appreciate that you may not have yet made the work, but please try and explain what your initial concept for the piece is, and how you aim to create the piece from this.

Q. Please include at least one URL link to online video material of this work or a previous work.

We encourage all applicants to share strong video links to support the application. Please only show choreographic ideas relating to the work described in the application, or previous choreographic works which are similar in style, or show a clear progression. These can be stages of research and development or previously filmed staged pieces. These are to support your written description of the work. We ask for 5 minutes maximum, and links that are easily accessible. If you have private Vimeo links, please provide the correct password as we will not have an opportunity to contact you later if it does not work.

Q. Does your work include any adult themes or have any trigger warnings?

Please let us know here if you plan to include any violence, adult language, nudity, themes of a sexual/adult nature and any trigger warnings. This is to ensure we're communicating to our audiences in advance what to expect. If these things are included later, you must tell us as soon as possible. Remember that themes you might not find explicit may be received differently by your audience.

Q. Does your work include strobe lighting?

Please let us know here if you plan to include a strobe lighting effect in your piece. This is to ensure we're communicating to our audiences in advance what to expect as this lighting effect can trigger medical conditions. If you are unsure or include the effect later, you must tell us as soon as possible.

Section 3 - PERFORMANCE DATES

Please tick as many dates as possible for which the piece is available. We offer 'End on' and 'In-the-round' configurations for this festival. Please be sure you know what these different configurations mean and how it will impact the work presented.

Everyone involved in the piece will need to be free the whole day to accommodate your technical rehearsal and performance. Ensure **before submitting** that you have checked the dates with your

collaborators and performers, so they are available to perform in the work. If selected for Resolution you will be programmed on one of these dates.

Please consider weekday dates as well as weekends. There are a limited number of weekend dates, so the larger the number of companies only choosing weekend dates, the higher the competition will be for those dates.

It is extremely unlikely that you will be able to change your performance date once it has been allocated to you. Successful applicants will know their confirmed performance date by September 2025.

Section 4 - TELL US ABOUT YOUR COMPANY

Q. Please give the names of the company members, their role and where appropriate, their training.

Please provide details of all people involved in the performance and making of the piece. Even if you are applying as an individual choreographer rather than a company, we ask that you add details for all performers as well, so we can assess the relevant artistic quality and experience of all involved.

You can tell us about:

- The training and experience of the artists.
- Who they have worked with in the past.
- Where they are based.

If you are applying with a group choreography, then you must have considered all your performers when applying.

Q. Can you confirm that all your company members have valid ID and have the right to work in the UK? (E.g. passport or visa)

All company members must be eligible to work in the UK during the time of the festival, and nearer the time you must provide evidence to the festival team which proves this. If a company member is awaiting a visa or proof of eligibility to work in the UK, please note this here.

Q. Can you confirm all your company members are over 18 years old?

All company members must be over 18 years old or will be by Friday 22 August 2025.

Q. Please give a short description of the choreographer/company's recent professional experience. This can include professional development activities such as workshops.

Please explain what previous professional development you have undertaken. This is to help us understand how you are developing your individual voice as a choreographer, company or performance maker. If you prefer you can hyperlink to a CV.

Section 5- FUNDING AND SUPPORT FOR THE WORK

Q. Are you applying for funding to make this work?

If you have any funding applications attached to the making of the work, please let us know, including when you expect to hear whether you have been successful.

Q. Will you still make the work if this funding application is unsuccessful?

It is especially important to let us know if you won't go ahead with making the piece if you are unsuccessful in these applications.

Q. Are you supported by an organisation? If so who, and how are they supporting you?

It is not necessary to be funded or supported by an organisation to take part in Resolution, however if you are receiving support we would like to know.

Section 6- MARKETING YOUR SHOW AT RESOLUTION

In this section we want to know about how you are intending to market your work at Resolution, and how to make your night stand out from the crowd. The Place helps to market Resolution as a festival overall, however companies are responsible for marketing the individual nights and encourage their audiences to come along. Unfortunately, we don't have a ready-made audience for your show,

but we aim to help support you in engaging and developing your audiences.

We would like you to think creatively about your ideas to engage your audiences and to consider a timeline for your marketing activities.

Section 7- PROFESSIONAL DEVELOPMENT WORKSHOPS

In this section we're asking you to confirm that you're available to attend the compulsory workshops as detailed in the Professional Development Workshops section of the application form. More information about each workshop can be found in the Resolution 2026 Toolkit PDF.

Section 8 – REFERENCE

In this section we're asking you to provide the name, job title, and contact information (phone number and email address) for **ONE** professional reference who can speak to your skills and experience.

The reference can be someone you have previously or currently work with or an educational institution.

Section 9 – REVIEW AND UNDERSTANDING THE DECLARATIONS

Q. If successful do you agree to give permission for your email address to be shared with the other companies performing on your night so that you can cross-promote.

Please declare here whether you are happy for us to share your email address with the other companies sharing your night.

Q. Financial declaration

To cover our running costs, the theatre takes £1605 of the net box office income for each night of Resolution. Any box office income which exceeds this amount is divided equally between the three companies who share the night. If you don't sell enough tickets to cover this £1605, you must pay the theatre the remaining balance which is also divided equally between the three companies who share the night. There are no upfront costs. If you have any questions or would like further clarification on this, please contact us at resolution@theplace.org.uk.

Q. The Place is committed to making dance accessible so if you have any learning or access needs, please let us know now so that we can support you through the Resolution process. This information will be confidential to the theatre team.

Please let us know this information here. If you would prefer not to share this information or would like to provide it in a different way, please leave this section blank.

Lastly, we ask that applicants complete an Equal Opportunities Monitoring Form. The Place is committed to providing equality, fairness and respect for all.
